CONTRACT MUST HAVE ALL FIELDS SIGNED & COMPLETE IN ORDER TO BE PROCESSED

Setup Time: 1:00 – 5:00 P.M. Friday, June 2nd

**ALL booths must remain open until 10:00 P.M.
The Event will be open to the public at 6:00 P.M.**

Vendors will be PROHIBITED without Special Event License on file at the chamber by Friday, May 26th. ALL VENDOR FEES ARE NON-REFUNDABLE.

Each exhibitor must make an application individually with one exhibitor per booth.

The 2017 Block Party will have exclusive vendors. No 2 vendors selling the same items will be allowed unless you are a member of the Pell City Chamber of Commerce. First come, first serve.

Notification of acceptance or rejection will be communicated to you as soon as possible.

The Committee reserves the right to refuse any vendor.

Pell City businesses and Pell City Chamber members take priority over all other applicants.

Vendors are responsible for all items needed in booth spaces and all must fit into the space provided including: **vehicles, trucks, trailers, hitches, tents, & tables.**

Ice must be provided by the Vendor

Please **list ALL food and non-food items you intend to sell.** Any food or non-food item that is not listed on your **application**, and approved by the Pell City Chamber of Commerce Block Party Committee, may be rejected.

If you need **electrical hookups**, you must check the appropriate box on the application form. The Block Party Committee **MUST have this information and payment in advance.**

Volunteers will be available to help you to your spot. Volunteers can be found along Cogswell Ave. No vehicles will be allowed in these areas.

The Block Party Committee reserves the right to reject any material it deems unsuitable. No stink bombs, snakes, snap-n-pops, or silly string allowed. All exhibitors are expected to comply with pertinent State of Alabama tax regulations

Advertising will begin prior to the show consisting of radio, newspaper, banners, & other means.

Applications must be signed and filled out in its entirety where applicable. Please type or print clearly.

- I hereby grant the Greater Pell City Chamber permission to use any photos taken of my booth to be used as they see fit.
- I, the undersigned exhibitor, hereby make application for booth space for sale purposes in the Hometown Block Party. The Pell City Chamber of Commerce and the City of Pell City shall not be held responsible for any injury or loss that may occur or come to the exhibitor or his assistants, or his goods for any cause whatsoever, while premises are being occupied under this agreement.

The Hometown Block Party Committee hereby reserves the right to cancel its agreement at any time immediately upon verbal notice and to revoke all rights of exhibitor in connection therewith, including compelling any exhibitor to remove his product and exhibit from the premises of the Hometown Block Party.
